On behalf of the President of India, tenders are invited through e-Tendering by the Director (Health), Directorate of Health and Family Welfare Services, Puducherry, from reputed manufacturers or their authorised dealers / importers for **Supply of “Medicines / Drugs – Tablets, Injections, IVFs, etc. including Hygiene Chemicals”** for Health Institutions of U.T. of Puducherry.

The bidder, after having valid Digital Signature Certificate (DSC) can obtain the USER ID and password from NIC, Puducherry, with which only, the bidder be able to download the Press Notice; Notice Inviting Tender and other related documents and upload the bid documents on-line on the official website <https://pudutenders.gov.in>. The tender details, terms and conditions, time schedule may also be downloaded from the linked website <https://www.py.gov.in> & <http://health.puducherry.gov.in> for reference only. The Bidder who had downloaded the Tender Schedule from the website shall submit the Tender Schedule online before the scheduled time of submission. The tender forms will be electronically issued to the Bidders only on payment of Tender Fee of Rs.2290/-(inclusive of VAT) through internet banking enabled account with any of the list of Banks available in the SBI e-Pay. (Annexure – A)

The Bidder must pay the EMD as detailed below through internet banking enabled account with any of the list of Banks available in the SBI e-Pay.

i. In case of tender is a manufacturer and submit tender only for their products	Rs.25,000/-
ii. In case of tenderer submits tender on behalf of a single manufacturer unit in the capacity of authorised distributor	Rs.25,000/-
iii. In case of tenderer submits tender on behalf of two or more manufacturer	Rs.25,000/- on behalf of each manufacturer, i.e. if quoted for two companies, the EMD is Rs.50,000, If quoted for three companies, the EMD is Rs.75,000. If quoted for several companies, the EMD should be paid proportionately.

The Technical Bid Documents should be submitted to the Chairperson, Tender Committee, Directorate of Health & Family Welfare Services, Health Complex, Rue Victor Simonel, Puducherry -1, in a sealed cover superscribing **“Tender for Medicines / Drugs – Tablets, Injections, IVFs, etc. including Hygiene Chemicals”** on or before **18.12.2015 @ 17.00 hrs.**
