NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Notification No. F5/4/65-GP, dated the 11<sup>th</sup> January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi, His Excellency the Lieutenant Governor hereby makes the following rules regulating the method of recruitment to **Group 'A' (Gazetted) post of "Naturopathy and Yoga Therapist"** in the Department of Indian Systems of Medicine & Homeopathy, Puducherry, namely:-

1. *Short title and commencement* – (i) These rules may be called the Government of Puducherry, Department of Indian Systems of Medicine & Homeopathy, **"Naturopathy and Yoga Therapist"** (Group 'A' Non-Ministerial Recruitment Rules, 2017.

(ii) They shall come into force from the date of its publication in the official Gazette.

2. *Number of posts, its classification and level of pay in pay matrix* – The number of the said post, its classification and Level of Pay in Pay Matrix, attached thereto, shall be as specified in columns 2 to 4 of the Schedule annexed hereto.

3. *Method of recruitment, age limit and other qualifications* – The method of recruitment to the said post, age limit, qualification and other matters relating thereto, shall be as specified in columns 5 to 13 of the said schedule.

4. *Disqualifications* – No person

(a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax* – where the Lieutenant Governor is of the opinion that it is necessary or expedient so to do, he may, by order in consultation with the Union Public Service Commission and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons

6. *Saving* – Nothing in those rules shall affect the reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard
