The candidates mentioned in the select list are required to appear for verification of their original certificates in the Directorate of Indian System of Medicine & Homoeopathy, No.29, Rue De la Compagnie Street (Old Secretariat Building), Puducherry-605001 on **25.01.2017** at 10:00 a.m. along with the following certificates in original:-

- i. Birth Certificate
- ii. S.S.L.C. Mark Sheet
- iii. H.Sc. or its equivalent
- iv. Diploma in Pharmacy (Ayurveda/Siddha/Homoeopathy/Unani) or its equivalent awarded by recognized University / Institution alongwith year-wise/semester-wise mark sheets.
- v. Fresh Community certificate. Candidates claiming reservation under SC category should belong to a caste which is recognized as Scheduled Caste under "The Constitution of India (Pondicherry) Scheduled Castes Order, 1964" dated 05.03.1964 read with "The Constitution of India (Scheduled Caste) Orders (Second Amendment) Act 2002 (Central Act 61 of 2002).
- vi. Fresh Nativity/Residence certificate for continuous residence of 5 years previous to the date of notification.
- vii. Employment Registration Card.

3. Provisional selection has been made purely on the basis of the information provided by the individuals in their applications. If the information provided by them is found to be false or not correct at the time of certificate verification, their selection will automatically stand cancelled without any notice.

4. The Provisional selection of those who fail to produce the required certificates at the time of certificate verification will automatically stand cancelled without any notice.

5. The Candidates who are selected are subject to the following conditions.

- i) The candidates who have not completed the required training as prescribed in the Recruitment Rules should undergo in-service training after their appointment.
- ii) Necessary age relaxation to the selected candidates who have been sponsored by the Employment Exchange should be obtained from the Govt. before the offer of appointment is issued to them as per G.O.Ms.No.22/92-Lab. Dated 28.08.1992 of the Labour Department, Puducherry.
- iii) Verification/Production of Nativity/Resident/Caste Certificates obtained within 3 months from the date of notification or afresh at the time of verification.
- iv) In respect of the selection of the candidate for the post of Pharmacist (Unani), approval of the Hon'ble Lieutenant Governor who is empowered/competent in accordance with Rule 5 of the Recruitment Rules should be obtained to relax the provision of required educational qualification.

6. The above selection is subject to the outcome of OA No.310/00417/2016, No.310/00418/2016 dt.11.03.2016 and No.310/00351/2016 dt.25.02.2016 pending before the Hon'ble CAT (Madras Bench).

7. The provisional selection/certificate verification will not confer any right on them to claim appointment as a matter of right.
