Sub: Chief Secretariat (Health) – Fixation of fee for Post Graduate Medical / Dental for the academic year 2017-18 – Orders – Issued.


Ref: 1. Letter No. Nil dated 12.05.2017 of the Chairman, Fee Committee, Puducherry.
 2. This Secretariat's Order of even No. dt. 14.05.2017.

In the light of the order passed by the Hon'ble High Court, Madras, in WMP 13777/2017 in WP No. 12912 of 2017 to the effect that the order passed by the Government of Puducherry on 14.05.2017 fixing the fee structure for the time being based on the Tamil Nadu Fee Committee order for ensuing Post Graduate admission, the Committee met again on 23.05.2017 and reviewed and reconsidered the fee structure for Post Graduate Medical/Dental courses. Accordingly, in supersession of order second cited above, the Committee has fixed the following fee structure temporarily/provisionally as stated below for the academic year 2017-18 which is subject to revision after getting the proposal, if any, from the colleges.

3. The above fee structure is subject to the following conditions:-

- i. The fee structure prescribed above will take effect from the academic 2017-18, current academic year.
- ii. This arrangement is purely temporary and it is provisional only, till the Fee Committee, Puducherry meets and fixes the fee structure permanently.
- iii. An undertaking may have to be obtained from the Students / Parents that the fee is being collected subject to the fees that would be permanently fixed by the Fee Committee, Puducherry.



- iv. This fee is an all inclusive annual fee including various fees like admission fee, Tuition fee, Special fee, Laboratory/ Computer / Maintenance and Amenities fee, Extracurricular activities fee and other recurring expenditure.
- v. In addition to the above fees, the institutions are permitted to collect an amount of Rs.50,000/- per student as development fee.
- vi. The management is directed to cover all the Students under Students Group Insurance Scheme.
- vii. The above fee does not include Hostel, Transport, Mess charge etc.
- viii. The Committee directs that the intuitions' shall not charge either directly or indirectly any other amount over and above the amount fixed as fees. If any, other amount is charged under any other head or guise e.g. donations, the same would amount to charging of capitation fee
- ix. Any deviations of this order will entail serious penal consequences like withdrawal of approval of MCI and disaffiliation by the concerned University as well as imposition of fine.
- x. The Committee directs that if the Colleges do not submit their proposal for fixation of fees, if any, on or before 30.06.2017, from the date of issue of this order, the fee fixed above will be treated as final one.
