The Medical Council of India vide the letter cited above has stated that the matter of admission of PG Students (Broad- Specialty) at Pondicherry Institute of Medical Sciences for the academic year 2017-18 was considered by the Monitoring Sub-Committee at its meeting held on 11-10-2017. The Committee noted that

“the allocation of seats made through common counseling by the State Govt. is final. It is not an internal affair of the institution/university concerned. Hence the committee reiterates its earlier decision as the change of subject is not permissible at college level. The withdrawal of discharge notice as requested by the institute is not permissible.

Accordingly, the request made by the college vide its letter dated 1-8-2017 for withdrawal of discharge notice cannot be accepted”
