
Sub: Health Secretariat – Re-fixation of fee for the Post Graduate Medical Courses for the academic year 2017-18 & 2018-19 - Regarding.

With reference to your letter cited above, I am directed to state that, a meeting was held on 20.02.2018 under the Chairmanship of Hon'ble Justice S. Rajeswaran, High Court Judge (Retd.), Chairman, Fee Committee, with the all the Private Medical/Dental Colleges including your College to revise/re-fix the fee structure for the Post Graduate Medical/Dental courses for the academic year 2017-18. The Fee Committee after careful examination of the proposals received from various Medical/Dental Colleges including your Institute in its subsequent meeting held on 06.03.2018, has fixed the fee structure for the Post Graduate Medical/Dental Courses for the academic years 2017-18 and 2018-19. In accordance with various judgement of the Hon'ble Supreme Court of India and based on the recommendations of the Fee Committee, the Government of Puducherry has issued G.O. Ms. No. 8 dated 22.03.2018, which is the final fee structure for all the Medical/Dental Colleges of this Union Territory of Puducherry.

2.. Therefore, the request made by you for re-fixation of fee structure for the Post Graduate Medical courses for the academic year 2017-18 & 2018-19, is "**Rejected.**" You are therefore directed to ensure strict compliance of the G.O. Ms. 8, dated 22.03.2018, failing which stringent action will be taken against the College for non-compliance of the G.O. and for committing contempt of the Hon'ble Supreme Court's orders in this regard.
