NOTIFICATION

WHEREAS the Directorate of Health & Family Welfare Services, Puducherry has notified 25 vacancies vide advertisement No.A.12020/1/2013/E4/DHFWS dated 17.05.2013 in the newspapers for wide publicity among the residents of the Union Territory of Puducherry to apply for the post of ANM / Maternity Assistant and to the Employment Exchange, Puducherry to sponsor the eligible and qualifying candidates registered with the Employment Exchange for recruitment of candidates of the Union Territory of Puducherry to the post of ANM / Maternity Assistant by direct recruitment.

AND WHEREAS in response to the Department's Notification dated 17.05.2013 and the panel of candidates sponsored by the Employment Exchange, Puducherry, the applications of candidates who have applied for recruitment to the post of ANM / Maternity Assistant received by this Directorate as on 21.06.2013 by 05:45 p.m. have been examined as per the existing Recruitment Rules for the post of ANM / Maternity Assistant in respect of educational and other qualifications required for direct recruits mentioned in column 8 of the RR.

AND NOW based on the recommendation of the Recruitment Committee during the Meeting held on 03.09.2013, the **candidates whose names are indicated in the select list given hereunder** are provisionally selected to offer appointment to the post of ANM / Maternity Assistant in the order of merit against unreserved vacancies and in the order of merit in their respective categories to which they have applied considering methodology of selection communicated in the G.O.Ms.No.19 dated 27.03.2012 of the Chief Secretariat (Health), Puducherry taking into account of 50% of marks obtained in Matriculation or its equivalent and 50% of marks obtained in the Diploma in Multipurpose Health Worker (Female) or Diploma in Auxillary Nurse Midwife or its equivalent granted by the Board of Medical Education, recognized by the Government after deducting 5% of marks for every additional attempt in the requisite educational and technical qualification(s). In addition to the above, 1.5 marks per every completed year of seniority from the date of registration of requisite educational or technical qualification(s), wherever applicable, in the Employment Exchange to the last date of receipt of duly filed in application will be added, subject to a maximum of 15 marks." Selection is made of the persons possessing knowledge of the regional language of Tamil, Malayalam or Telugu, as the case may be, according to the availability of vacancies in Puducherry and Karaikal and Mahe regions and availability of eligible candidates in the respective categories, subject to the following conditions :-

The candidates who are selected under the Meritorious Sports Person quota and Physically Handicapped candidate shall be offered appointment to the post of ANM / Maternity Assistant subject to verification of his / her original Meritorious Sports Certificate, Meritorious Sports Person Certificates issued by the Competent Sports Authority with the original certificates awarded by the authorities of the related games / sports in the prescribed form and in respect of the Physically Handicapped candidate, the Medical Certificate issued by the Competent Medical Authority, Government of Puducherry, respectively.
3. Offer of appointment shall be issued subject to availability of vacancies in the Health Institutions in the respective regions of the Union Territory of Puducherry and fulfilling other conditions and requirements as per rules and regulations in force. The candidates who have been provisionally selected for the post of ANM / Maternity Assistant will be issued offer of appointment only on production of Permanent Registration Certificate issued by any one of the State Nursing & Midwifery Councils in India, besides furnishing of original certificates in support of their Educational, Technical qualifications, Nativity, Caste certificates and Employment Registration card etc for verification.
