In continuation to the Memorandum third cited, the candidates who are declared to have been provisionally selected for the post of Refrigeration Mechanic vide notification second cited, are directed to appear for certificate verification in the Directorate of Health & Family Welfare Services, Victor Simmonel Street, Old Maternity Hospital Building, Puducherry – 605001 on 28.11.2016 at 02:30 p.m.

2. They shall produce the following certificates in original together with its copies duly attested by a Gazetted Officer at the time of Certificate verification :

- a. Birth Certificate / Board certificate indicating the date of birth
- b. SSLC / Matriculation mark sheets or its equivalent
- c. ITI Trade Certificate in Refrigeration and Air-conditioning issued by a Govt. recognized institution with mark sheets.
- d. Training certificate
- e. Experience certificate for 3 years
- f. Nativity / Residence certificate issued (by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar) on or after 26.08.2015.
- g. Community Certificate obtained in the prescribed form issued (by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar) on or after 26.08.2015
- h. Employment Exchange Registration Card.

3. The Candidates claiming reservation under SC category should belong to a Caste which is recognized as Scheduled Caste under "The Constitution of India (Pondicherry) Scheduled Castes Order, 1964" dated 05.03.1964 read with "The Constitution of India (Scheduled Caste) Orders (Second Amendment) Act, 2002 (Central Act 61 of 2002).

4. Provisional selection has been made purely on the basis of the information provided by the individuals in their application. If the information provided by them is found to be false or not correct at the time of certificate verification, their selection will automatically stand cancelled without any notice.

5. The provisional selection of those who fail to produce the required certificates at the time of certificate verification will automatically stand cancelled without any notice.

- a. Provisional selection/certificate verification will not confer any right to claim appointment as a matter of right.
- b. Failure to appear for certificate verification as per the schedule given above will lead to cancellation of the provisional selection without any notice.
- c. No extension of time will be granted to produce the original certificates.
- d. No TA will be paid for attending the certificate verification
