The candidates mentioned in the select list are required to appear for verification of their original certificates in the Directorate of Health & Family Welfare Services, Victor Simmonel Street, Old Maternity Hospital Building, Puducherry-605001 on **10.01.2017** at 02:30 p.m. along with the following certificates in original:-

- i. Birth Certificate
- ii. S.S.L.C. & H.Sc. or its equivalent Mark Sheets
- iii. Certificate of having undergone Special Training in a Filaria Training Centre recognized by the Government / Degree in the Field of Filariasis
- iv. Fresh Community certificate obtained within a period of one year preceding the date of Notification i.e. on 04.01.2017, in the prescribed form issued by an Officer of the Department of Revenue and Disaster management not below the rank of Deputy Tahsildar. Candidates claiming reservation under SC category should belong to a caste which is recognized as Scheduled Caste under "The Constitution of India (Pondicherry) Scheduled Castes Order, 1964" dated 05.03.1964 read with "The Constitution of India (Scheduled Caste) Orders (Second Amendment) Act 2002 (Central Act 61 of 2002).
- v. Fresh Residence certificate by continuous residence in the Union Territory for the last 5 years immediately preceding the date of notification i.e., on 04.01.2017, issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar.
- vi. Employment Registration Card.

3. Provisional selection has been made purely on the basis of the information provided by the individuals in their applications. If the information provided by them is found to be false or not correct at the time of certificate verification, their selection will automatically stand cancelled without any notice.
