**NOTIFICATION**

WHEREAS the Directorate of Health & Family Welfare Services, Puducherry has notified 42 vacancies vide notification No.A.12020/1/2010/E4/DHFWS dated 14.04.2010 in the newspaper for wide publicity among the residents of the Union Territory of Puducherry to apply for the post of Auxillary Nurse Midwife / Maternity Assistant and to the Employment Exchange, Puducherry to sponsor the eligible and qualifying candidates registered with the Employment Exchange for recruitment of candidates of the Union Territory of Puducherry to the post of Auxillary Nurse Midwife / Maternity Assistant by direct recruitment.

2. AND WHEREAS in response to the Department's Notification dated 14.04.2010 and the panel of candidates sponsored by the Employment Exchange, Puducherry, the applications of candidates who have applied for recruitment to the post of Auxillary Nurse Midwife / Maternity Assistant received by the Directorate as on 14.05.2010 including the candidates' applications received by the Department during the year 2004 vide the Directorate's Notification No.A.12020/4/2004/E4/DHFWS dated 27.05.2004 and kept in abeyance in the Department for recruitment to the post of Auxillary Nurse Midwife / Maternity Assistant have been examined, based on the verdict of the Hon'ble High Court, in the High Court of Judicature at Madras in Writ Petition Nos. 28572 of 2004, 14203, 9097 and 9098 of 2007 dated 04.08.2009 have been examined as per the Recruitment Rules for the post of Auxillary Nurse Midwife / Maternity Assistant notified vide G.O.Ms.No.44 dated 27.08.2009 of the Chief Secretariat (Health), Government of Puducherry, in respect of educational and other qualifications required for direct recruits mentioned in column 8 of the RR.

3. AND NOW based on the recommendation of the Recruitment Committee during the Meeting held on 13.09.2010, the candidates whose names are indicated in the select list given hereunder are provisionally selected to offer appointment to the post of Auxillary Nurse Midwife / Maternity Assistant including two additional candidates in the category of Scheduled Caste against two vacancies occurred in the Health Institutions, after this Department's notification dated 14.04.2010, in the order of merit against unreserved vacancies and in the order of merit in their respective categories to which they have applied for, taking into account of 100 marks obtained in Matriculation or its equivalent and 100

marks obtained in the Diploma in Multipurpose Health Worker (Female) or Diploma in Auxillary Nurse Midwife or its equivalent granted by the Board of Medical Education, recognized by the Government, after deducting 5% of marks in Matriculation or its equivalent and Diploma in Multipurpose Health Worker (Female) or Diploma in Auxillary Nurse Midwife or its equivalent for every additional attempt as per G.O.Ms.No.78 dated 18/12/2008. Selection is made of the persons possessing knowledge of the regional language of Tamil, Malayalam or Telugu, as the case may be, according to the availability of vacancies in Puducherry and Karaikal, Mahe and Yanam regions of Union Territory of Puducherry vide G.O.Ms.No.44 dated 27.08.2009 of the Chief Secretariat (Health), Government of Puducherry and based on the availability of eligible candidates in the respective categories, subject to the following conditions.

4. The candidates who are selected under the Meritorious Sports Person quota and Physically Handicapped quota shall be offered appointment to the post of Auxillary Nurse Midwife / Maternity Assistant subject to verification of his / her original Meritorious Sports Certificate, Meritorious Sports Person Certificates issued by the Competent Sports Authority with the original certificates awarded by the authorities of the related games / sports in the prescribed form and in respect of the Physically Handicapped candidate, the Medical Certificate issued by the Competent Medical Authority of the Government Hospitals in the Government of Puducherry and by the Officer of the Department sponsoring the candidate for appointment to the post in the Government under PH quota, respectively.

5. Offer of appointment shall be issued subject to availability of vacancies in the Health Institutions in the respective regions of the Union Territory of Puducherry and fulfilling other conditions and requirements as per rules and regulations in force. The candidates who have been provisionally selected for the post of Auxillary Nurse Midwife / Maternity Assistant will be issued offer of appointment only on production of Permanent Registration Certificate of Midwife registered in any one of the State Nursing & Midwifery Councils in India, besides furnishing of original certificates in support of their Educational, Technical qualifications, Nativity Certificate by virtue of continuous residence in the Union Territory of Puducherry for

a period of not less than 5 years, MBC / OBC / SC Certificate or Permanent Integrated Certificate issued or revalidated by the Competent Revenue Authority on or after 01.01.2010, respectively with Original Employment Registration card, etc., for verification.
