NOTIFICATION

WHEREAS the Directorate of Health & Family Welfare Services, Puducherry has notified 88 vacancies vide notification No.A.12020/1/2010/E4/DHFWS dated 14.04.2010 in the newspaper for wide publicity among the residents of the Union Territory of Puducherry to apply for the post of Health Assistant and to the Employment Exchange, Puducherry to sponsor the eligible and qualifying candidates registered with the Employment Exchange for recruitment of candidates of the Union Territory of Puducherry to the post of Health Assistant by direct recruitment.

AND WHEREAS in response to the Department's Notification dated 14.04.2010 and the panel of candidates sponsored by the Employment Exchange, Puducherry, the applications of candidates who have applied for recruitment to the post of Health Assistant received by the Directorate as on 14.05.2010 including the candidates' applications received by the Department during the year 2004 vide the Directorate's Notification No.A.12020/4/2004/E4/DHFWS dated 27.05.2004 and kept in abeyance in the Department for recruitment to the post of Health Assistant have been examined based on the verdict of the Hon'ble High Court, Chennai in Writ Petition No.47866 of 2006 and Miscellaneous Petition No.1/2006 dated 04/08/2009.

AND NOW based on the recommendation of the Recruitment Committee during the Meeting held on 03.09.2010, the candidates whose names are indicated in the select list given hereunder are provisionally selected to offer appointment to the post of Health Assistant in the order of merit against unreserved vacancies and in the order of merit in their respective categories to which they have applied for, by awarding marks corresponding to 100 marks in SSLC or equivalent examination and 100 marks in the Diploma / Degree in Pharmacy with a deduction of 5% of marks for every additional attempt in the general and technical examinations and by adding 1.5 marks per every completed year of seniority from the date of registration of the requisite qualification acquired in the Employment Exchange to the date of notification of vacancies, subject to a maximum of 15 marks, in accordance with the G.O.Ms.No.78 dated 18.12.2008 of Chief Secretariat (Health), Puducherry, subject to the following conditions :-

The candidates who are selected under the Meritorious Sports Person quota shall be offered appointment to the post of Health Assistant subject to verification of his / her original Meritorious Sports Certificate, Meritorious Sports Person Certificates issued by the Competent Sports Authority with the original certificates awarded by the authorities of the related games / sports in the prescribed form, respectively.

3. Offer of appointment shall be issued subject to availability of vacancies in the Health Institutions in the respective regions of the Union Territory of Puducherry and fulfilling other conditions and requirements as per rules and regulations in force and furnishing of original certificates by the selected candidates in support of their Educational, Technical qualifications, Nativity, Caste certificates and Employment Registration card, respectively.
