NOTIFICATION

WHEREAS the Directorate of Health & Family Welfare Services, Puducherry has notified 15 vacancies vide notification No.A.12020/1/2010/E4/DHFWS dated 14.04.2010 in the newspaper for wide publicity among the residents of the Union Territory of Puducherry to apply for the post of Pharmacist (Allopathy) and to the Employment Exchange, Puducherry to sponsor the eligible and qualifying candidates registered with the Employment Exchange for recruitment of candidates of the Union Territory of Puducherry to the post of Pharmacist (Allopathy) by direct recruitment.

2. AND WHEREAS in response to the Department's Notification dated 14.04.2010 and the panel of candidates sponsored by the Employment Exchange, Puducherry, the applications of candidates who have applied for recruitment to the post of Pharmacist (Allopathy) received by the Directorate as on 14.05.2010 including the applications of unsuccessful candidates as received from the candidates, by the Department during the year 2004 vide the Directorate's Notification No.A.12020/4/2004/E4/DHFWS dated 27.05.2004 for recruitment to the post of Pharmacist (Allopathy) have been examined, based on the verdict of the Hon'ble High Court, in the High Court of Judicature at Madras in Writ Petition Nos. 28572 of 2004, 14203, 9097 and 9098 of 2007 dated 04.08.2009 have been examined as per the Recruitment Rules for the post of Pharmacist (Allopathy) notified and published in the Supplement to the Gazette dated 19.05.1970 (G.O.Ms.No.8/70/H&FPS/ dated 12.03.1970 of the Health Secretariat, Government of Puducherry), in respect of educational and other qualifications required for direct recruits as mentioned in the column 7 of the Recruitment Rules.

3. AND NOW based on the recommendation of the Recruitment Committee during the Meeting held on 29.09.2010, the candidates whose names are indicated in the select list given hereunder are provisionally selected to offer appointment to the post of Pharmacist (Allopathy) including two additional candidates in the category of Most Backward Class and one candidate in Scheduled Caste against three vacancies occurred in the Health Institutions, after this Department's notification dated 14.04.2010, in the order of merit against unreserved vacancies and in their respective categories to which they have applied for, taking into account of 100 marks obtained in SSLC or its equivalent

and 100 marks in the Diploma / Degree in Pharmacy granted by the Board of Medical Education / University recognized by the Government, after deducting 5% of marks in SSLC or its equivalent and Diploma / Degree in Pharmacy for every additional attempts with additional marks i.e., 1.5 marks for every year of completed seniority from the date of registration of requisite qualification acquired in the Employment Exchange to the date of notification of vacancies subject to a maximum of 15 marks (i.e., Maximum marks 100+100+15=215) vide G.O.Ms.No.78 dated 18/12/2008 of the Chief Secretariat (Health), Government of Puducherry, Puducherry.

4. The candidates who are selected under the Meritorious Sports Person quota and Physically Handicapped quota shall be offered appointment to the post of Pharmacist (Allopathy) subject to verification of his / her original Meritorious Sports Certificate, Meritorious Sports Person Certificates issued by the Competent Sports Authority of the Government with the original certificates awarded by the authorities (Federation / Associations of the games) of the related games / sports in the prescribed form and in respect of the Physically Handicapped candidate, the Medical Certificate issued by the Competent Medical Authority of the Government Hospitals in the Government of Puducherry and by the Officer of the Department sponsoring the candidate for appointment to the post of Pharmacist (Allopathy) in the Government under PH quota, respectively.

5. Offer of appointment will be issued subject to availability of vacancies in the Health Institutions in the respective regions of the Union Territory of Puducherry and fulfilling all other conditions and requirements as per rules and regulations in force. The candidates who have been provisionally selected for the post of Pharmacist (Allopathy) will be issued after verification of their original certificates and registration of their qualification in the Pharmacist Register of the Puducherry Pharmacy Council of the Health Department as on date. In respect of the candidates who have already registered their qualification in the Pharmacist register of the Puducherry Pharmacy Council, offer of appointment to such candidates will be issued after renewal of their registration certificate up-to-date by the Puducherry Pharmacy Council, respectively, besides furnishing of original certificates in support of their Age, Educational, Technical qualifications, Nativity Certificate by virtue of continuous residence in the Union Territory of Puducherry for a period of not less than 5 years, MBC / OBC / SC Certificate or Permanent Integrated Certificate issued or revalidated by the Competent Revenue Authority on or after 01.01.2010, with the Original Employment Registration card, duly renewed up-to-date by the Employment Officer, Employment Exchange, Puducherry, for verification.
