NOTIFICATION

WHEREAS the Directorate of Health & Family Welfare Services, Puducherry has notified 59 vacancies vide notification No.A.12020/1/2010/E4/DHFWS dated 14.04.2010 in the newspaper for wide publicity among the residents of the Union Territory of Puducherry to apply for the post of Staff Nurse and to the Employment Exchange, Puducherry to sponsor the eligible and qualifying candidates registered with the Employment Exchange for recruitment of candidates of the Union Territory of Puducherry to the post of Staff Nurse by direct recruitment.

AND WHEREAS in response to the Department's Notification dated 14.04.2010 and the panel of candidates sponsored by the Employment Exchange, Puducherry, the applications of candidates who have applied for recruitment to the post of Staff Nurse received by the Directorate as on 14.05.2010 have been examined as per the existing Recruitment Rules for the post of Staff Nurse in respect of educational and other qualifications required for direct recruits mentioned in column 8 of the RR.

AND NOW based on the recommendation of the Recruitment Committee during the Meeting held on 03.09.2010, the candidates whose names are indicated in the select list given hereunder are provisionally selected to offer appointment to the post of Staff Nurse in the order of merit against unreserved vacancies and in the order of merit in their respective categories to which they have applied for, taking into account the aggregate of the percentage of marks obtained in Higher Secondary or equivalent and the percentage of marks obtained in Diploma or Degree in Nursing and Midwifery/Psychiatric Nursing or its equivalent, after deducting 5% of marks in Higher Secondary and Diploma / Degree in Nursing and Midwifery/Psychiatric Nursing or its equivalent for every additional attempt as per G.O.Ms.No.55 dated 27.07.2001. Selection is made of the persons possessing knowledge of the regional language of Tamil, Malayalam or Telugu, as the case may be, according to the availability of vacancies in Puducherry and Karaikal, Mahe and Yanam regions of Union Territory of Puducherry vide G.O.Ms.No.62 dated 04.10.2001 of the Chief Secretariat (Health), Govt. of Puducherry and availability of eligible candidates in the respective categories, subject to the following conditions :-

The candidates who are selected under the Meritorious Sports Person quota and Physically Handicapped candidate shall be offered appointment to the post of Staff Nurse subject to verification of his / her original Meritorious Sports Certificate, Meritorious Sports Person Certificates issued by the Competent Sports Authority with the original certificates awarded by the authorities of the related games / sports in the prescribed form and in respect of the Physically Handicapped candidate, the Medical Certificate issued by the Competent Medical Authority, Government of Puducherry, respectively.

3. Offer of appointment shall be issued subject to availability of vacancies in the Health Institutions in the respective regions of the Union Territory of Puducherry and fulfilling other conditions and requirements as per rules and regulations in force. The candidates who have been provisionally selected for the post of Staff Nurse will be issued offer of appointment only on production of Permanent Registration Certificate issued by any one of the State Nursing & Midwifery Councils in India, besides furnishing of original certificates in support of their Educational, Technical qualifications, Nativity, Caste certificates and Employment Registration card etc for verification.
